A regular meeting of the Common Council of the City of Boscobel, Wisconsin was called to order by Mayor Steve Wetter.

Motion by Alder Roger Brown to approve minutes of the September 19, 2016 Common Council meeting as presented. Motion seconded by Alder Brenda Kalish. Motion carried.

Motion by Alder Roger Brown to approve a UDAG Commission recommendation to approve a \$60,000.00 UDAG loan to Raymond Saint, DBA Family Martial Arts & Wellness Center, for the purchase of property located at Hwy. 61 & Madison Street and to construct a building for the business. Loan will be amortized over 20 years (240 months) and will bear 2.25% interest. Motion seconded by Alder Nancy Sanger. Upon roll call vote, all Alders voted aye. Motion carried

Motion by Alder Milton Cashman to approve issuing a CLASS "B" Retailers License (*Picnic*) to Boscobel Antique Club for their 10-15-2016/10-16-2016 event. Motion seconded by Alder Nancy Sanger. Motion carried.

Motion by Alder Milton Cashman to approve purchasing a 2017 Ford Explorer Police Interceptor Squad Car from Fillback Motors for \$27,077.50; delivery is expected in December. Motion seconded by Alder Brenda Kalish. Upon roll call vote, all Alders voted aye except Alder Barbara Bell and Alder Roger Brown who abstained. Motion carried.

Motion by Alder Gary Kjos to approve contracting with FEHR Graham to provide employee safety program services for 2017 for \$3,820.00; cost is the same as 2016 and will be split with Boscobel Utilities as it was in 2016. Motion seconded by Alder Brenda Kalish. Upon roll call vote, all Alders voted aye. Motion carried.

Motion by Alder Milton Cashman to approve Pay Request #4 and final; Contract #2 (*excavating*) for \$16,386.63 from Reynolds Brothers, LLC, Boscobel, for the 2016 Streets Improvement Project - Chestnut Street. Motion seconded by Alder Brenda Kalish. Upon roll call vote, all Alders voted aye. Motion carried.

Motion by Alder Brenda Kalish to approve Pay Request #1 and final; Contract #4 (*blacktop*) for \$56,800.78 from Iverson Construction, Kieler, for the 2016 Streets Improvement Project - Chestnut Street. Motion seconded by Alder Gary Kjos. Upon roll call vote, all Alders voted aye. Motion carried.

DPW, Mike Reynolds, reported the 2016 Streets Improvement Project on Chestnut Street, Contract #3, (*concrete*) will have an additional request for payment. Recycling Grant has been submitted to the DNR. No street project is planned for 2017; all three blocks of Adams Street will be done in 2018. No official action was taken.

Motion by Alder Brenda Kalish to approve issuing a Bartender's License to Ashley Vale, New Horizons. Motion seconded by Alder Gary Kjos. Motion carried.

Chief Stenner reported that the "Stuff the Cruiser" event at Piggly Wiggly was very successful. Two squad cars were filled with \$850.00 to \$1,000.00 in two hours; groceries were given to the Food Pantry. No official action was taken.
